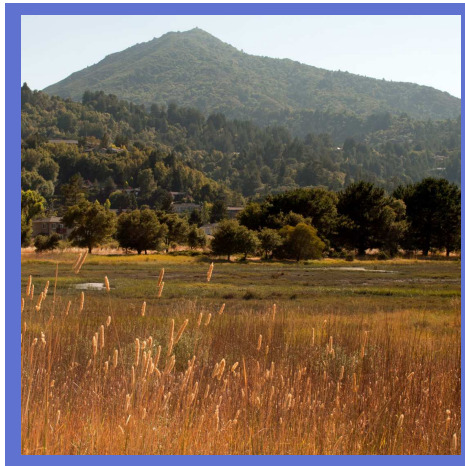

As we enjoy the start of a very special 2021-2022 school year, please know that the programs, services and most important, the people of the Marin County Office of Education are here to support you, your families and our community.



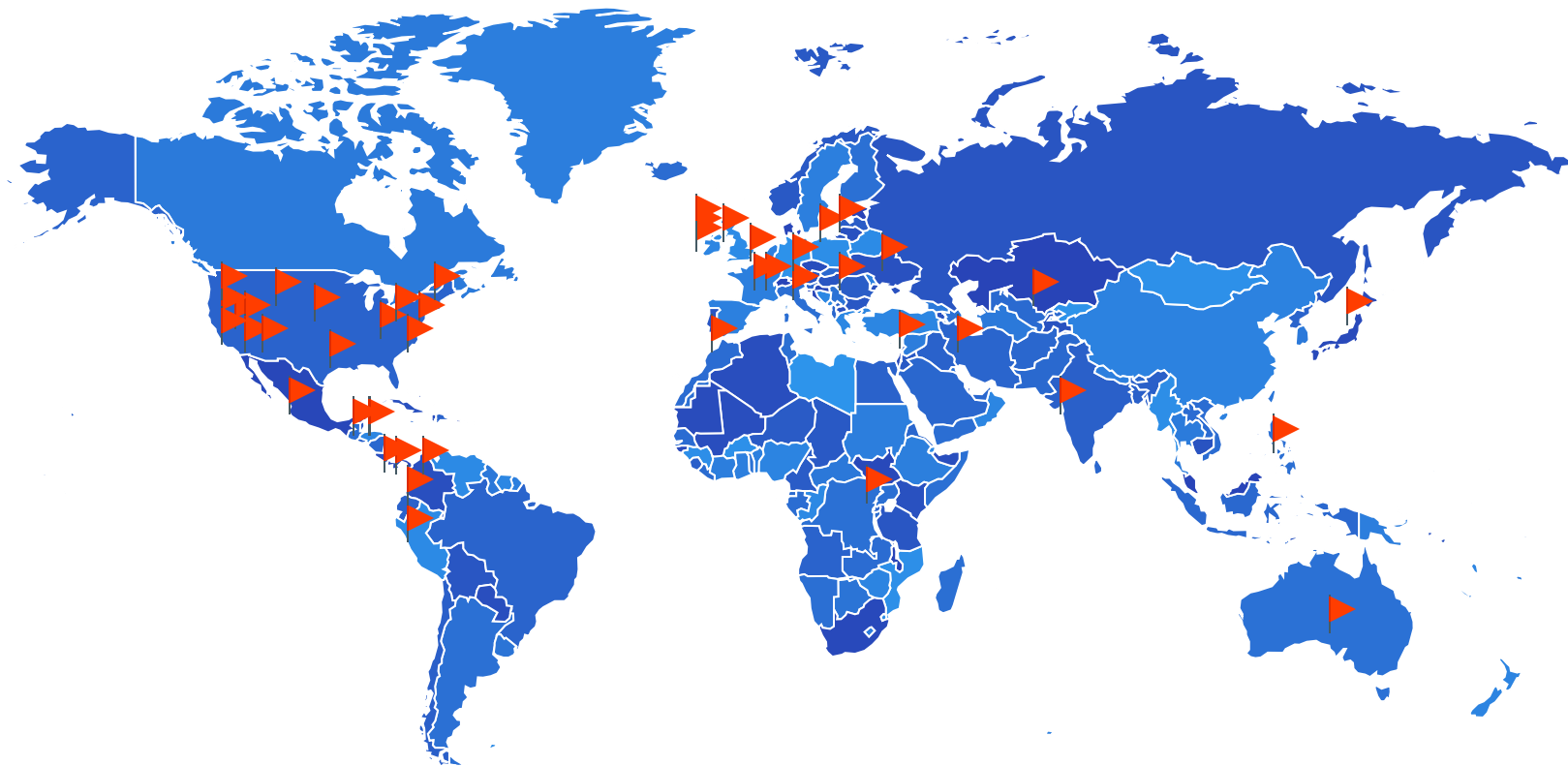

SPECIAL EDUCATION PROGRAM

The Special Education Department of the MCOE operates regionalized special education classrooms (Teachers, Paraprofessionals, School Psychologists, Occupational Therapists, Speech and Language Pathologists, School Nurses, etc.) and provides several itinerant special education services (Teacher of the Visually Impaired, Teachers of the Deaf and Hard of Hearing, etc.) to help meet the educational needs of students with Individualized Education Programs (IEPs) within Marin County.

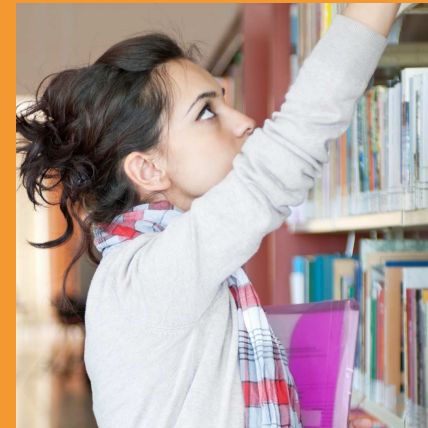

RETHINKING SCHOOLS TASK FORCE

The Rethinking Schools (RTS) Task Force, initiated by the Marin County Superintendent of Schools in the Spring of 2020, worked in sync with Public Health to develop and implement health and safety protocols to safely return students and staff to in-person classroom instruction in the age of COVID-19. The collaboration was recognized as a best practice by the U.S. Department of Education in the ED COVID-19 Handbook: Roadmap to Reopening Safely and Meeting All Students' Needs.

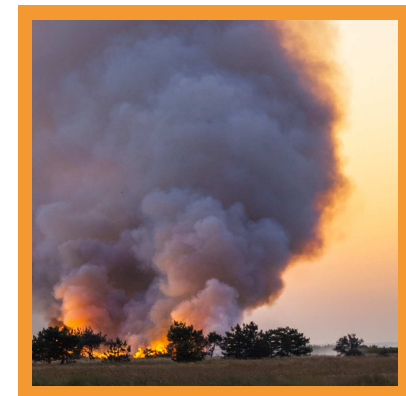

PERSONNEL SERVICES

The Personnel Services department supports approximately 275 permanent employees, 100 substitutes, extra-hire staff and professional experts, and over 375 county wide substitute teachers by coordinating and monitoring employee benefits, workers' compensation and state disability claims. The Marin County Office of Education's Credentials Analyst serves as a liaison between the county public schools and the California Commission on Teacher Credentialing (CTC) and supports all teachers countywide with renewing or adding credentials and applying for documents. In addition, the County Office of Education convenes a countywide personnel meeting to discuss topics of common interest and maintains the Marin County substitute teacher list.

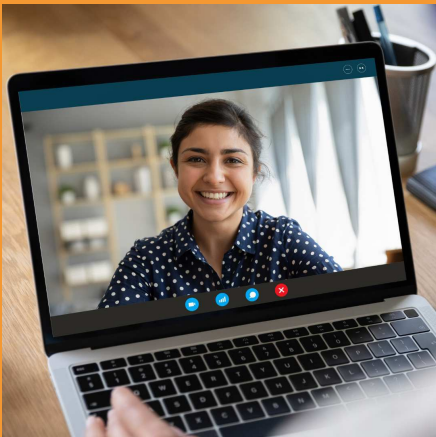

WALKER CREEK RANCH

Walker Creek Ranch began operating Outdoor Education and Conference Center programs in April 1990. The Ranch is located in West Marin, encompassing 1,741 acres with numerous buildings, a one-acre pond, organic garden, extensive hiking trail system, and its own potable water and sewage treatment facilities. Fuel reduction, trail maintenance, and repair to the main water line are a few of the significant projects completed recently.



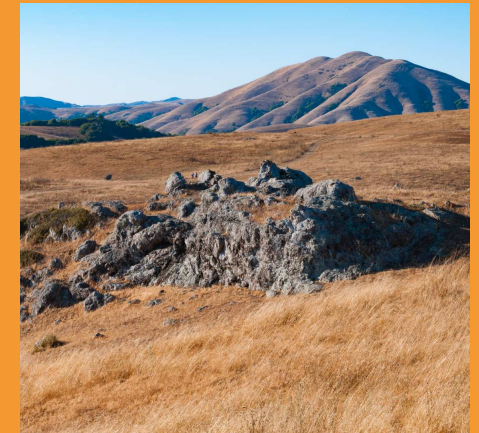
